Description

PROJECT RATIONALE AND OBJECTIVES

STDP is under the umbrella of the (TouRIST) Program of the DOT or the Transforming Communities towards Resilient, Inclusive and Sustainable Tourism. Created by the Department Order 2019-101 in line with RA 9593 and the National Tourism Development Plan, the program's goal is to develop resilient, inclusive and sustainable tourism destinations. The Sustainable Tourism Development Project (STDP) is aimed at making El Nido and Coron's tourism development sustainable, resilient and inclusive. It has three major components which are urban infrastructure, ecosystem improvement and enterprise development.

As part of the preparatory activities of the project, the regional office will conduct ocular inspection and small group consultations with stakeholders in getting ready for the implementation of the project in late 2022 or early 2023.

Specifically, the project aims to:

- Monitor the proposed areas included in the STDP;
- Meet the stakeholders involved in the implementation of the project; and
- Assess the effectivity of the health and safety protocols of Coron and El Nido in relation to preventing the spread of COVID 19 virus.
