Description

I. BACKGROUND/PROJECT DESCRIPTION

Sons of Luzon 1st Freedom Ride Festival is the biggest and most awaited motorcycle show in the Philippines showcasing premium motorcycle models, accessories and equipment happening on November 25-27, 2022 at Liwasang Ulalim, CCP Complex Parking Grounds, Pasay City.

The event also offers the widest range of exhibitors in the industry and exclusive access to custom motorcycle scene, bringing together various builders and independent brands that celebrate the culture and lifestyle of riding. A study by ADB mentioned that roughly 14% of households in Metro Manila reported that they own cars, exceeding

the country percentage, while almost 12% own motorcycle. The 2022 semi-annual registry of Land Transportation Office reveals that in 2022, Metro Manila has around 1,759,413 registered motorcycles.

Indeed, Metro Manila is considered motorcycle-friendly. The proliferation of Angkas, Joyride as well as Grab Delivery using motorcycles as a means of transportation in Metro Manila means the interest in this two-wheeled vehicle is on high gear. Recently, the move to push for Philippine Motorcycle Tourism is also gearing up and Metro Manila cannot be far from this endeavor. This motorcycle show is but a manifestation of such interest.
