II. PROJECT TITLE: First PCSSD Underwater Clean-Up Drive and Crown-of-Thorns Mitigation in TICAD Marine Reserve, Tindog, Medellin, Cebu

III. RATIONALE AND OBJECTIVES

The crown-of-thorns starfish (frequently abbreviated to COTS), Acanthaster planci, is a large starfish that preys upon hard, or stony, coral polyps (Scleractinia). The crown-of-thorns starfish receives its name from venomous thorn-like spines that cover its upper surface, resembling the biblical crown of thorns. It is one of the largest starfish in the world. An outbreak occurs when there are around thirty (30) COTS in one hectare.

According to a WWF survey, in the Philippines outbreaks of crown-of-thorns starfish have been reported at Apo Reef and Puerto Galera in Mindoro, as well as at Mabini in Batangas, Roxas in Palawan, Bolinao in Lingayen Gulf, and Kiamba and Glan in Sarangani Bay February of 2022. Outbreaks were also reported on Moalboal, Malapascua and Medellin in Cebu.

On the outbreak in Moalboal, Cebu, during an interview of Rappler to Dr. Brisneve Edullantes, a marine biologist from the University of the Philippines-Cebu, said that the number of COTS in Moalboal is alarming.

"If the population of crown-of-thorns starfish is left unchecked, the COTS outbreak can cause damage to coral reefs," Brisneve stressed to Rappler.

The biologist said a COTS outbreak would most likely affect the livelihood of fishermen, since an abundance of commercially valuable reef fish may decline in COTS-infested reefs.

For dive destinations, dive operators, Local Government Units and National Agencies work together with volunteers to help mitigate the outbreaks. However, in areas like Medellin in Cebu which is not a dive destination, mitigation had been challenging.

In line with the PCSSD's effort to continue to promote safe diving tourism and environmental conservation and protection, the PCSSD will commence its pilot program in Underwater Clean-Up Drive and Crown-of-Thorns Mitigation in TICAD Marine Reserve, Tindog, Medellin, Cebu to provide immediate assistance and control to the COTs outbreak they are having.

PCSSD will be conducting the said pilot project in TICAD Marine Reserve in Tindog, Medellin, Cebu on 02 December 2022. This project is targeting the local community, volunteer divers, specifically the local divers in the area.

This project aims to:

- To educate the community and local divers in the nature of COTS, why they thrive and how it affects them in general;
- To provide knowledge and skills to the community in COTS Mitigation from extraction to disposal;
- Create awareness and provide knowledge to the community on the COTS natural predators for natural mitigation;
- To create plans and programs with the community to prevent future outbreak in the area.
