Description

OBJECTIVE: The Welcome Lei Reception for the port of calls of Cruise Ships in MIMAROPA Region is anchored on the following objectives:

1. Create a pleasant welcoming atmosphere for cruise ships on port call in the MIMAROPA Region;
2. Introduce Filipino hospitality to guests and crew alighting from cruise ships; and
3. Build networks with cruise ship operators and local government units to ensure continuous flow of arriving tourists through cruise ships.

MINIMUM REQUIREMENTS:

1. Must have been in the production business for at least 2 years
2. Must be able to provide services on a Send-Bill Arrangement
3. Must have PhilGEPS Registration.

SCOPE OF WORK/DELIVERABLES:

Wooden Leis Specifications (See Annex A):

- Hand weave Regular overhead bleach or colored native beads wax cord leis from wood in different colors, sizes and shapes;
- 18" - 20" (nape to pendant);
- Engraved MIMAROPA logo in a Rectangular Wood (Bamboo wood material used in tumblers) Pendant;
- Bidder must submit design with their quotation; and
- Minimum of 15,000 pcs.

PAYMENT SCHEMES
