INVITATION TO BID (IB)

The Philippine Department of Tourism (PDOT), through the Bids and Awards Committee (BAC), invites suppliers/contractors to bid for the hereunder project. Considering that the Philippine booth is to be set-up at the venue of the event in Tel Aviv, Israel, bidders with company based or has an affiliate in Israel, will be preferred.

Name of Project: **Design, Set-up and Dismantling of the Philippine Booth for the International Mediterranean Tourism Market (IMTM) 2019**

Brief description of the Project: Services of a company engaged in the business of designing, set-up and dismantling of booths for travel and consumer fairs for the Philippine Stand at the IMTM 2019

Approved Budget for the Contract: Sixty-Five Thousand US Dollars (USD 65,000.00) or its Philippine Peso equivalent, inclusive of taxes, chargeable against 2019 funds. This project is subject to "early procurement short of award".

Contract Duration: One (1) week

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility check, Preliminary Examination of Bids, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
