



SUPPLEMENTAL/BID BULLETIN NO. 1

This Supplemental/Bid Bulletin is issued to all prospective bidders to clarify, modify and/or amend items in the Bidding Documents as discussed and agreed during the Pre-Bid Conference held on 15 September 2021 for the ***Procurement of a Service Provider for the Printing/Production of 2021 DOT Accreditation Stickers for Tourist Transport Vehicles, Tourism Enterprises and Other Tourism-Related Enterprises and 2021 DOT Accreditation Certificates (DOT-BAC-IB No. 2021-010)***.

I. The following clarifications are provided for the guidance and reference of the shortlisted bidders:

Listed are the questions and clarifications from the bidders	Answers and Applied amendments in the Terms of Reference
<p>1. If the submission of the SLCC should be per lot and how much is the percentage of the ABC?</p>	<p>Yes, submission of SLCC is per lot.</p> <p>Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC.</p> <p>For this purpose, similar contracts shall refer to the following:</p> <p>Lot No. 1 – stickers, accreditation stickers or stickers in the form of signages</p> <p>Lot No. 2 – certificates, accreditation certificates, or accreditation stickers</p>
<p>2. Can a bidder bid only on 1 lot?</p>	<p>Yes, partial bid is allowed.</p> <p><i>Section 19.2 of Section II Instruction to Bidders of the Bidding Docs states that:</i></p> <p><i>If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by ITB Clause 15 shall be submitted for each lot or item separately.</i></p>

Listed are the questions and clarifications from the bidders	Answers and Applied amendments in the Terms of Reference
<p>3. For the submission of similar sample, how many samples should be submitted for the AD Stickers and AD Certificates?</p>	<p>For Lot No. 1 - Stickers: - Five (5) Total Samples • One (1) size for Tourism Establishments • Four (4) sizes for Transport Vehicles</p> <p>For Lot No. 2 - Certificates: - One (1) Sample for the Certificate with Stars</p>
<p>4. If the lay-out will be provided by the End-User?</p>	<p>The layout was posted/published together with the bidding documents.</p>
<p>5. For the schedule of prices, how will they represent the prices?</p>	<p>The prospective bidder should indicate the unit price per piece as indicated in the TOR.</p>

This shall form an integral part of the Bidding Documents.
