PROJECT : DISASTER RISK REDUCTION SEMINAR WORKSHOP

DATE/VENUE OF IMPLEMENTATION : 11 - 13 October 2023 / Tanay, Rizal

BACKGROUND/RATIONALE :

The Philippines was ranked the third in the 2018 World Risk Index of most disaster-prone countries in the world being located along the boundary of major tectonic plates or the so-called Ring of Fire (referring to a large Pacific Ocean region where many of the earth's volcanic eruptions and earthquakes occur). Every year, the country experiences almost all forms of disasters such as typhoons, earthquakes, and volcanic eruptions with numerous complex emergencies due to armed conflict, fire and other man-made disasters.

In its continuous effort in strengthening the capacity of its workforce and in advancing the Department's resiliency to deal and cope with the effects of disasters that are brought about by natural and human induced hazards. The TDD acknowledges the importance of staging this seminar and drill not only as a means to comply with the Occupational Safety and Health Standard (OSHS) for accreditation, but to make sure everybody is prepared when disaster strikes.

The Department of Tourism (DOT) as a member agency of the National Disaster Risk Reduction Management Council (NDRRMC), is duty bound to capacitate its workforce on emergency preparedness and response to mitigate the effects and imminent dangers of any hazards or disasters such as fire and earthquakes. With this, our Training and Development Division (TDD) together with the DOT Disaster Risk Reduction and Management (DOT DRRM) and in cooperation with the NDRRMC will conduct the "Disaster Risk Reduction Seminar Workshop" to be held on 11 - 13 October 2023.

OBJECTIVES

By the end of this seminar the participants should be able to: Overreach the aims and objectives of disaster preparedness; Define the terms hazards, disasters and vulnerability; Identify of different types of disasters; Learn the scope of disaster preparedness measures; and the concept of community-based disaster
