## Description

Date of Implementation: June 14 – 19, 2023 Venue: Iloilo City, Western Visayas, Philippines

Objectives:

1. Showcase the rich culture, natural wonders, and tourism assets of each of the Central Philippine regions through a 3-day travel trade exposition and promote the various destinations and its existing and new tourism products.

2. Increase tourism arrivals through Domestic Tourism

3. Engage with tourism stakeholders and local government units in the marketing and promotional efforts of the Department

Scope of Service

The service provider should be able to provide the transportations, transfers, and hosted meals with the following specifications:

A. General Requirements

• Service Provider should be a DOT-Accredited Tour Operator

Inclusive Date: June 14 - 19, 2023

- Amenable to send-bill arrangement/government procedure
- Price quotation should be denominated in the Philippine Peso and inclusive of 12% VAT and all other applicable taxes and charges. Price validity shall be for a period of one hundred twenty (120) calendar days.
- Tour Operator must be based in NCR or MIMAROPA Region

- B. Documentary Requirements
- 1. Mayor's/Business Permit
- 2. DTI/SEC Permit
- 3. Proof of PhilGEPS Registration
- 4. Omnibus Sworn Statement
- 5. DOT Accreditation Certificate
- C. Specific Requirements

1. Transportation (Airfare)

• Roundtrip flight ticket with 20 kgs baggage allowance per pax to MNL-ILO-MNL for ten (10) pax (June 14 – 19, 2023)

• Roundtrip flight ticket with 20 kgs baggage allowance per pax to MNL-ILO-MNL for thirty-five (35) pax (June 15 – 19, 2023)

- 2. Transportation (Van Hire)
- Air-conditioned van (at least 12-seater) with stored supplies of face mask, face shield, and alcohol (sanitation kits);
  Must conform to the following itinerary:
- Whole day of 1 unit of van (12 hours) within Iloilo City on June 14, 2023
- Whole day of 4 units of van (12 hours) within Iloilo City on June 15 19, 2023

3. Venue and Meals

- Managed dinner buffet for 125 pax on June 17, 2023 (Date TBC)
- Venue must be located within Iloilo City and must be DOT Accredited Accommodation Establishment or MICE Venue Facility
- Venue must have a maximum capacity of 250pax
