To strengthen the Department Order 2018-14, Prescribing the New Guidelines on the Endorsement of Tourism Investments by the Department of Tourism to the Board of Investments (BOI) and the Philippine Economic Zone Authority (PEZA), the Office of Tourism Standards and Regulation - Project and Investment Evaluation Division (OTSR-PIED) will be conducting the Tourism Investment Regional Officers' Retooling Seminar to give the Regional Offices' Investment Officers an update on new investment laws and give a refresher course on the processes of endorsement.
