BRIEF BACKGROUND:

The DOT NCR will be manning the 54-sqm booth allocated and will be facilitating the games to fully promote and market the capital's newest product. The DOT NCR will be procuring giveaways, prizes, and food sampling to entice travel fair visitors to engage on the interactive booth. The DOT NCR will be preparing tokens for DOT, attached agencies such as TPB and TIEZA officials, and heads of tourism associations as DOT Regional Offices all over the country are also expected to attend and participate the said travel fair.
