BRIEF BACKGROUND & BRIEF PROJECT DESCRIPTION:

With reference to the recently-concluded Luncheon Meeting of DOT Secretary Christina Garcia-Frasco with Accredited Tour Guides in NCR held on 11 May 2023 in Casa Blanca, Intramuros, Manila, the tour guide associations who attended the said event are requesting for the conduct of Regional Tour Guiding Seminar for tour guides who wish to be DOT-accredited. It was attended by fifty (50) accredited tour guides in NCR to a simple luncheon with Secretary Christina Garcia-Frasco in celebration of the 50th founding anniversary of the DOT, and was a way to recognize the frontliners' efforts to champion Philippine tourism amid the pandemic and various challenges. Tourism Frontliners such as the Tour Guides have invaluable role in the tourism industry. Tour Guide with specific area qualification leads tour groups or individual visitors through a particular attraction, activity, site, or destination and provides interesting or enlightening facts and information or interpretation, for a fee, commission, or any other form of lawful remuneration. In NCR, there are accredited 196 Regional Tour Guides, and 5 Community Tour Guides. Tour Guides all over the country have organized themselves and formed several Tour Guides Organization. The following are organizations based in the National Capital Region (NCR), namely, Philippine Association of Accredited Tourist Guide Lecturers, Inc (PAATGLI), Accredited Tourist Guides Services Cooperatives Inc (ACTSCOOP), Guides Inc., Multi-Lingual Accredited Tour Guides Association of the Philippines (MULATGAP), Japanese-Speaking Tour Guides Association (JASTA), Philippine Federation of Professional Tour Guides Association Inc. (TGFED), and Fort Santiago Volunteer Tour Guides, Inc.
