PROJECT RATIONALE AND OBJECTIVES

The Department of Tourism will be hosting series of Panel Discussions for the first Philippine Tourism Dive Dialogue, which aims to engage the relevant partners in the dive industry to discuss current issues and concerns of the industry, including sustainability efforts, safety and standards for scuba diving, marine conservation and protection,

market attractiveness, investment opportunities, and promotions. Invited speakers, panelists, and moderators will be provided with economy roundtrip airline tickets. During the event, the DOT-TRCRG will be hosting a welcome dinner and briefing of invited facilitator, moderators, speakers, panelists, DOT Regional Directors, Technical Working Group, and other government officials and VIPs on September 13, 2023. The Office will host a Dive Familiarization Trip for the invited panelists, speakers, and other members of the Technical Working Group in Mactan, Cebu on September 15-17, 2023 for dive product assessment and promotions.

Diving with air/nitrox tanks, dive equipment rental (e.g., air tanks, BCDs, booties, weights, fins, masks, regulators, and wetsuits), boat rental, services of dive guides, and all applicable environmental and sanctuary/marine park fees No. of persons: 20 persons

Meals and Drinks: Provide full-board meals of the participants - September 15 (dinner only), September 16 & 17 (breakfast, lunch, and dinner). Unutilized rooms and dives, if any, must not be charged to the DOT and excluded from the final billing
