RESOLUTION NO. 2024-004

BAC Resolution Recommending the Use of Negotiated Procurement – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as an Alternative Method of Procurement, Awarding the Contract to Beat and Beads Event Management for the conduct of “Welcome Reception for the Arrival of Cruise Calls in Manila on February 2024”

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act” provides that in order to promote economy and efficiency, the Procuring Entity may resort to any of the Alternative Methods of Procurement. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained;

WHEREAS, Section 53. Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services whereby the Procuring Entities directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, Section 53.6. Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services. Where Goods, Infrastructure Projects and Consulting Services can be contracted to a particular supplier, contractor or consultant and as determined by the Head of the Procuring Entity, for any of the following:

1. The requirement is for:

- a. Work of art; commissioned work or services of an artist for a specific artist skills (e.g., Singer, poet, writer, painter, sculptor, etc.);
- b. Scientific, academic, scholarly work or research, or legal services;
- c. Highly-specialized life-saving medical equipment, as certified by the Department of Health (DOH);
- d. Scientific, technical, economic, business, trade or legal journal, magazine, paper, subscription, or other exclusive statistical publications and reference; or
- e. Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

Due to the nature of the information to be disseminated, alongside principles of transparency, efficiency and economy, award to more than one (1) supplier may be made by the Procuring Entity.

WHEREAS, the Department of Tourism - NCR, thru Tourism Frontline Service Unit (TFSU) will conduct the “**Welcome Reception for the Arrival of Cruise Calls in Manila on February 2024**”, and is to provide cultural entertainment show for the arrival and departure consists of Ati-Atihan and Drum & Bugle Band. **The Approved Budget for the Contract (ABC) is Pesos: THREE HUNDRED THIRTY THOUSAND (Php330,000.00).**

WHEREAS, End-user has conducted market research and evaluated three known (3) cultural dance group, to wit;

- 1.) Ex-Link Management and Marketing Services Corporation (Ex-Links Event);
- 2.) Beat and Beads Events Management;
- 3.) Stagebrite Event Management.

WHEREAS, based on the market research provided by the End-user, the following ratings were gathered, to wit:



- a) To recommend Negotiated Procurement - Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services under Section 53.6 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (R.A 9184) for the **Awarding of Contract to Beat and Beads Events Management** for the cultural/entertainment requirements (arrival and departure) as specified in the Technical Specifications for the conduct of “**WELCOME RECEPTION FOR THE ARRIVAL OF CRUISE CALLS IN MANILA ON FEBRUARY 2024**”, and;
- b) To **Award the Contract to BEAT AND BEADS EVENTS MANAGEMENT** on the conduct of “Welcome Reception for the Arrival of Cruise Calls in Manila on February 2024, for the total amount of **PESOS: THREE HUNDRED THIRTY THOUSAND (Php330,000.00)**, inclusive of all applicable taxes.


- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
