Contract for the Procurement of Consulting Services for the Production, Content Creation, Printing, and Delivery of the Coffee Table Books

This Contract for the Procurement of Consulting Services for the Production, Content Creation, Printing, and Delivery of the Coffee Table Books ("Agreement") is made and entered into this 24th day of APRIL 2024 by and between:

The DEPARTMENT OF TOURISM (DOT), a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by **Assistant Secretary, GISSELA MARIE R. QUISUMBING** ("Procuring Entity");

and

VIBAL FOUNDATION INC., a private entity with business address at 3F Vibal Bldg., 1253 G. Araneta Avenue, Sto. Domingo, District 1, Quezon City, represented by its **Enterprise Sales Manager, RAFAEL D. DE VERA** ("Consultant");

Each a "Party" and collectively, the "Parties"

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the Contract for the Procurement of Consulting Services for the Production, Content Creation, Printing, and Delivery of the Coffee Table Books (DOT-SBAC-REI No. 2024-002) (hereinafter called "the Works") and the Procuring Entity has accepted the bid for **Fourteen Million Seven Hundred Ninety-Nine Thousand Five Hundred Sixty-Eight Pesos (Php14,799,568.00)**, inclusive of all applicable taxes, fees, and other charges, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, to wit:

 - (c) Request for Expression of Interest;
 - (d) Instruction to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.

In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
