

Contract for the Procurement of Consulting Services of a Social Media Management and Strategic Planning Agency

This Contract for the Procurement of Consulting Services of a Social Media Management and Strategic Planning Agency ("Agreement") is made and entered into this 24th day of MAY 2024 by and between:

The DEPARTMENT OF TOURISM (DOT), a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by Assistant Secretary, GISELA MARIE R. QUISUMBING ("Procuring Entity");

and

UNIVERSAL VISION SOLUTION COMMUNICATIONS INC., a private entity with business address at 1819 B Concepcion St., Brgy. Valenzuela, Makati City, represented by its CEO, BENEDICT R. YALUNG ("Consultant");

Each a "Party" and collectively, the "Parties"

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the Contract for the Procurement of Consulting Services of a Social Media Management and Strategic Planning Agency (DOT-SBAC-REI No. 2024-004) (hereinafter called "the Works") and the Procuring Entity has accepted the bid for **Seven Million Nine Hundred Ninety Thousand Pesos (Php7,990,000.00)**, inclusive of all applicable taxes, fees, and other charges, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.


