Contract for the Procurement of Marketing Collaterals for the Love the Philippines Activations through Sports Tourism

This Contract for the Procurement of Marketing Collaterals for the Love the Philippines Activations through Sports Tourism (Agreement) is made this, 10 July 2024 in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **ASSISTANT SECRETARY GISSELA MARIE R. QUISUMBING**, and hereinafter referred to as the "PROCURING ENTITY";

-and-

CRISTANELLE INTERNATIONAL INC., a private entity duly organized and existing under the laws of the Philippines, with business address at UGFC-4A Classica I Condo, 112 H.V. Dela Costa Street, Bel-Air, Makati City, duly authorized and represented herein by its **AUTHORIZED REPRESENTATIVE, HAROLD E. ESTIPONA** and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, the Procuring Entity invited Bids for certain goods and services, particularly the delivery of 29,895 pcs. of assorted marketing collaterals with a delivery date on August 16, 2024, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Million Three Hundred Eighty-Eight Thousand Three Hundred Nineteen Pesos (PhP5,388,319.00)**, inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of **Five Million Three Hundred Eighty-Eight Thousand Three Hundred Nineteen Pesos (PhP5,388,319.00)** inclusive of applicable taxes; or such other sums as may be ascertained, the SUPPLIER agrees to provide services for the delivery of 29,895 pcs. of assorted marketing collaterals in accordance with its Bid.
4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




