

BAC Resolution Declaring the Single Rated and Responsive Bid (SRRB) for the Procurement of Consultancy Services for the Philippines Hop-On Hop-Off (HOHO) Cebu Validation (DOT-NCR REI No. 2024-04-001)

RESOLUTION NO. 2024 - 059

WHEREAS, pursuant to approved Department of Tourism - National Capital Region (DOT- NCR) Bids and Awards Committee (BAC) Resolution No. 2024-050 dated 10 June 2024, Positive Exposure Productions Inc., being the Single Rated Bidder (SRB) for the Procurement of Consultancy Services for the Philippines Hop-On Hop-Off (HOHO) Cebu Validation (DOT-NCR REI No. 2024-04-001), was invited for the opening of the Financial Proposal and Negotiations on 10 June 2024, respectively, pursuant to the Competitive Bidding- Quality Based Evaluation (QBE) procedures of Republic Act, RA 9184 and its 2016 Implementing Rules and Regulations (IRR). A copy of the approved BAC Resolution No. 2024-050 and the Invitation to the Opening of the Financial Proposal and Negotiation sent to the SRB are hereto attached, and made an integral part hereof;

WHEREAS, during the opening of the Financial Proposal, Positive Exposure Productions, Inc. offered a bid price amounting Four Million Five Hundred Thousand Pesos (PHP 4,500,000.00), inclusive of all applicable taxes. The said amount is within the ABC, thus declared "passed" in the Financial Proposal. Consequently, Positive Exposure Productions Inc. proceeded with the negotiation stage;

WHEREAS, Department of Tourism - NCR (DOT-NCR) and Positive Exposure Productions, Inc., has successfully completed the negotiations, thus the latter shall be subject to Post-Qualifications. A copy of the Minutes of the Meeting is hereto attached, and made an integral part hereof;

WHEREAS, the bid of Positive Exposure Productions, was subjected to Post-Qualification for a careful examination, validation and verification of all statements made in the eligibility, technical and financial requirements submitted, and was likewise found responsive, thus 'post-qualified". A copy of the Post-Qualification report is hereto attached and made an integral part hereof;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a). To declare POSITIVE EXPOSURE PRODUCTIONS, INC. as the Single Rated and Responsive Bidder (SRRB) and award the contract for the Procurement of Consultancy Services for the Philippines Hop-On Hop-Off (HOHO) Cebu Validation, amounting Four Million Five Hundred Thousand Pesos (Php 4,500, 000.00), inclusive of all applicable taxes;
- b). To recommend for approval by the Head of Procuring Entity of the Department of Tourism – National Capital Region the foregoing findings.
