This *Contract for the Procurement of Consulting Services for International Media Placements through Integrated Branded Content for Philippine Destinations and Tourism Products* ("Agreement") is made and entered into this 2ND day of AUGUST 2024 by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by **Secretary, MA. ESPERANZA CHRISTINA GARCIA FRASCO** ("Procuring Entity");

and

UNIVERSAL VISION SOLUTION COMMUNICATIONS INC., a private entity with business address at 1819-B Concepcion Street, Brgy. Valenzuela, Makati City represented by its **Chief Executive Officer, BENEDICT R. YALUNG** ("Consultant");

Each a "Party" and collectively, the "Parties"

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the *Contract for the Procurement of Consulting Services for the International Media Placements through Integrated Branded Content for Philippine Destinations and Tourism Products (DOT-SBAC-REI No. 2024-010)* (hereinafter called "the Works") and the Procuring Entity has accepted the bid for **Ninety-Two Million Six Hundred Ninety Thousand Pesos (Php92,690,000.00)**, inclusive of all applicable taxes and charges, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.
