



**BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB)
and Recommending Award for the Procurement of Events Management
Company for the SALAM: The Halal Tourism and Trade Expo
Philippines 2024 on June 14-16, 2024
(DOT BAC-IB NO. 2024-009)**

Resolution No. 2024 090

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the "**Procurement of Events Management Company for the SALAM: The Halal Tourism and Trade Expo Philippines 2024 on June 14-16, 2024**" (DOT BAC-IB NO. 2024-009) in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 18 April 2024. The total Approved Budget for the Contract (ABC) of **Two Million Four Hundred Fifty-One Thousand Eight Hundred Forty-Eight Pesos (PHP 2,451,848.00)** inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, the Competitive Bidding Procedures for Goods and Services pursuant to the provisions of Republic Act No. 9184 (RA 9184) and its Implementing Rules and Regulations (IRR) was undertaken for purposes of this project;

WHEREAS, the BAC issued a Notice of Postponement announcing adjustment in the procurement schedules. A copy of Notice of Postponement is hereto attached, marked as **Annex "B"** and made an integral part hereof;

WHEREAS, a Pre-Bid Conference was held on 26 April 2024 which was attended by two (2) interested suppliers. Namely:

1. Kleal Entertainment Production
2. Total Exhibit and Expo Solutions, Inc.

WHEREAS, pursuant to the said Pre-Bid Conference, the BAC issued Supplemental/Bid Bulletin No. 1 announcing clarifications and amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "C"** and made an integral part hereof;

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. 2 announcing amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin No. 2 is hereto attached, marked as **Annex "D"** and made an integral part hereof;

WHEREAS, in response to said posting, **TOTAL EXHIBIT AND EXPO SOLUTIONS INC.** was the only interested bidder who purchased the bidding documents and submitted its bid proposal within the deadline set on 10 May 2024;

WHEREAS, during the opening of bids held on 10 May 2024, **TOTAL EXHIBIT AND EXPO SOLUTIONS INC.** was declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "E"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

- a) To declare **TOTAL EXHIBIT AND EXPO SOLUTIONS INC.** as the **Single Calculated and Responsive Bid (SCRB)** for the "Procurement of Events Management Company for the SALAM: The Halal Tourism and Trade Expo Philippines 2024 on June 14-16, 2024" (DOT BAC-IB NO. 2024-009) and award the contract in the total amount of **Two Million Three Hundred Ninety-Seven Thousand Pesos (PhP2,397,000.00)**, inclusive of applicable taxes; and
- b) To recommend for approval of the Secretary of Tourism the foregoing findings.
