



BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending Award for the Procurement of Tour Operator Services for the conduct of "Support to Product Development for Technical Diving" on June 27 to July 15, 2024
DOT-BAC IB NO. 2024-012

Resolution No. 2024 - 088

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Tour Operator Services for the conduct of "Support to Product Development for Technical Diving" on June 27 to July 15, 2024** in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 25 April 2024. The total Approved Budget for the Contract (ABC) of **Three Million Two Hundred Three Thousand Three Hundred Eight Pesos and 17/100 (PhP 3,203,308.17)** inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, a Pre-Bid Conference was held on 02 May 2024 which was attended by DONSOL ECO TOUR INC.

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. 1 announcing amendments to the schedule of procurement activities. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "B"** and made an integral part hereof;

WHEREAS, in response to said posting, **three (3)** interested bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 15 May 2024. Namely:

1. CCT 168 TRAVEL AND TOURS CORP.
2. JJA TRAVEL AND TOURS
3. DONSOL ECO TOUR INC.

WHEREAS, during the opening of bids held on 17 May 2024, all three (3) bidders were declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:
