RESOLUTION NO. 2024-054

BAC Resolution Recommending the Use of Negotiated Procurement – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as an Alternative Method of Procurement, Awarding the Contract of Service of CULTURAL PERFORMANCE for the DOT-NCR’s PARTICIPATION TO 75th ANNIVERSARY OF THE DIPLOMATIC RELATIONS BETWEEN THE PHILIPPINES AND THAILAND to SINDAW PHILIPPINES PERFORMING ARTS GUILD

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act” provides that in order to promote economy and efficiency, the Procuring Entity may resort to any of the Alternative Methods of Procurement. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained;

WHEREAS, Section 53. Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services whereby the Procuring Entities directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, Section 53.6. Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services. Where Goods, Infrastructure Projects and Consulting Services can be contracted to a particular supplier, contractor or consultant and as determined by the Head of the Procuring Entity, for any of the following:

1. The requirement is for:
 - a. Work of art; commissioned work or services of an artist for a specific artist skills (e.g., Singer, poet, writer, painter, sculptor, etc.);
 - b. Scientific, academic, scholarly work or research, or legal services;
 - c. Highly-specialized life-saving medical equipment, as certified by the Department of Health (DOH);
 - d. Scientific, technical, economic, business, trade or legal journal, magazine, paper, subscription, or other exclusive statistical publications and reference; or
 - e. Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

Due to the nature of the information to be disseminated, alongside principles of transparency, efficiency and economy, award to more than one (1) supplier may be made by the Procuring Entity.

WHEREAS, the Department of Tourism - NCR, requires cultural performance (services of performers/entertainers) as specified in the Technical Specifications for the “DOT-NCR’s Participation to the 75th Anniversary of the Diplomatic Relations between Philippines and Thailand on June 14, 2024. The Approved Budget for the Contract (ABC) is Pesos: **NINETY THOUSAND (PhP90,000.00)**.

WHEREAS, End-user has conducted market research and evaluated three known (3) cultural dance group, to wit;

- 1.) Ramon Obusan Folkloric Group
- 2.) Bayanihan Folk Arts Foundation Inc.
- 3.) Sindaw Philippines Performing Arts Guild.

WHEREAS, based on the market research provided by the End-user, the following ratings were gathered, to wit:

- a) To recommend Negotiated Procurement - Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services under Section 53.6 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (R.A 9184) for the Awarding of Contract to cultural performance (services of performers/entertainers) as specified in the Technical Specifications for the DOT-NCR's Participation to ~~7th~~ **8th Anniversary of the Diplomatic Relations Between the Philippines and Thailand on June 14, 2024**;
- b) To **Award the Contract** to **SINDAW PHILIPPINES PERFORMING ARTS GUILD** to provide cultural performance (services of performers/entertainers) as specified in the Technical Specifications for the **"DOT-NCR's Participation to 7th Anniversary of the Diplomatic Relations Between the Philippines and Thailand on June 14, 2024"**, for the total amount of **PESOS: NINETY THOUSAND (PhP90,000.00)**, inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
