BAC Resolution Recommending the Use of Negotiated Procurement – Small Value Procurement as an Alternative Method of Procurement, Declaring the Single Rated and Responsive Quotation (SRRQ) and Recommending Award to Pioneer Professional Academy of Asia Inc. for the Consultancy Services for the conduct of Filipino Brand of Service Excellence (FBSE) Trainings for 2<sup>nd</sup> Quarter of F.Y. 2024

WHEREAS, the Department of Tourism – National Capital Region (DOT-NCR), Tourism Development Division (TDD) through the General Services/Procurement Unit, posted the Request for Quotation (RFQ) for the procurement of Consultancy Services for the conduct of Filipino Brand of Service Excellence (FBSE) Trainings for 2nd Quarter of F.Y. 2024 in the PhilGEPS website, DOT Website, and in conspicuous place at the DOT Building for at least three (3) calendar days, starting on 3 April 2024, and the deadline for the submission of quotations was set on 08 April 2024. A copy of the PhilGEPS and DOT website postings are hereto attached, and made an integral part hereof;

WHEREAS, the Approved Budget for the Contract (ABC) is Pesos: Nine Hundred Seventy Five Thousand (PhP 975,000.00)

WHEREAS, seven (7) known service providers were invited to join by sending Request for Quotations (RFQ) via e-mail and to submit their quotation on a sealed bid at the DOT Office, in compliance with the procedure on Negotiated Procurement - Small Value Procurement pursuant to Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184);

WHEREAS, in response to the said posting and invitation, only PIONEER PROFESSIONAL ACADEMY OF ASIA INC. submitted its Eligibility Requirements and was found eligible on 08 April 2024;
