WHEREAS, the Department of Tourism National Capital Region (DOT NCR) Tourism Regulation Division (TDD) through the General Services/Procurement Unit, posted the Request for Quotation (RFQ) for Ground Handling Services for the DOT Advocacy Training Programs in PhilGEPS and DOT website continuously for at least three (3) calendar days, starting on 15 June 2024, and the deadline for the submission of quotations was set on 19 June 2024.
