

## BAC Resolution Declaring the Single Rated and Responsive Bid (SRRB) for the Procurement of Consultancy Services for the Integrated Marketing Communications Management (STRATCOM) of DOT-NCR (DOT-NCR REI No. 2024-06-002)

## **RESOLUTION NO. 2024 - 076**

WHEREAS, pursuant to approved Department of Tourism - National Capital Region (DOT- NCR) Bids and Awards Committee (BAC) Resolution No. 2024-074 dated 22 July 2024, Carbon Digital Inc., being the Single Rated Bidder (SRB) for the Procurement of Consultancy Services for the Integrated Marketing Communications Management (STRATCOM), was invited for the opening of the Financial Proposal and Negotiations on 23 July 2024, respectively, pursuant to the Competitive Bidding- Quality Based Evaluation (QBE) procedures of Republic Act, 2184( RA 9184) and its 2016 Implementing Rules and Regulations (IRR). A copy of the approved BAC Resolution No. 2024-074 and the Invitation to the Opening of the Financial Proposal and Negotiation sent to the SRB are hereto attached, and made an integral part hereof;

WHEREAS, during the opening of the Financial Proposal, Carbon Digital, Inc. offered a bid price amounting One Million Six Hundred Thousand Pesos (PHP 1, 600, 000.00), inclusive of all applicable taxes. The said amount is within the ABC, thus declared "passed" in the Financial Proposal. Consequently, Carbon Digital Inc. proceeded with the negotiation stage;

WHEREAS, Department of Tourism - NCR (DOT-NCR) and Carbon Digital, Inc., has successfully completed the negotiations, thus the latter shall be subject to Post-Qualifications. A copy of the Minutes of the Meeting is hereto attached, and made an integral part hereof;


WHEREAS, the bid of Carbon Digital Inc., was subjected to Post-Qualification for a careful examination, validation and verification of all statements made in the eligibility, technical and financial requirements submitted, and was likewise found responsive, thus 'post-qualified". NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


