RESOLUTION NO. 2024-064

BAC Resolution Recommending the Use of Negotiated Procurement – Lease of Real Property and Venue as an Alternative Method of Procurement, Declaring the Single Calculated and Responsive Quotation and Recommending Award to THE MARQUIS EVENTS VENUE BGC, INC.

WHEREAS, the Department of Tourism – National Capital Region (DOT-NCR), through the Tourism Development Division (TDD), will be participating in the hosting of Modern and Contemporary Art Festival (MoCAF) 2024 on July 02-08, 2024. The DOT-NCR is in need of events venue that will also provide package including meals, lights and sound equipment within Taguig City and can accommodate up to 1000 guests. The Approved Budget for the Contract (ABC) is **Two Million Only (PhP 2,000,000.00)**;

WHEREAS, Section 53.10 of the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), allows the Procuring Entity to resort to Negotiated Procurement – Lease of Real Property or Venue for official use;

WHEREAS, pursuant to Clause 9 of Annex H of Republic Act No. 9184 and its Revised Implementing Rules and Regulations, the DOT-NCR Bid and Awards Committee (BAC) shall send the Request for Quotations to at least three (3) events venue;

WHEREAS, the Request for Quotation was sent via email to the following Events venue preferably located within Taguig City and to submit their quotations on or before 28 June 2024, to wit:

1. Grand Hyatt Hotel
2. The Marquis Events Venue BGC
3. Shangri-La The Fort

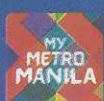
WHEREAS, in response to said invitation, only one (1) bidder submitted its quotation on 28 June 2024, to wit:

WHEREAS, the quotation submitted by The Marquis Events Place Inc., being the Single Calculated and Responsive Quotation, was in accordance with the Market Study prepared by the Project Officer pursuant to Appendix C with guidelines for Lease of Privately Owned Real Property and Venue. A copy of the Market Study is hereto attached, as an integral part hereof;

NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT-NCR Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:



- a) To adopt Negotiated Procurement – Lease of Venue under Section 53.10 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (R.A 9184) for the procurement of Lease of Venue that can also provide package including meals, lights and sound equipment within Taguig City and can accommodate up to 1000 guests for the hosting of the Modern and Contemporary Art Festival (MoCAF) 2024 on July 02-08, 2024, and;
- b) To declare The Marquis Events Venue BGC Inc. as the Single Calculated and Responsive Quotation and to award the contract for hosting of the Modern and Contemporary Art Festival (MoCAF) 2024 on July 02-08, 2024, in the total amount of **PESOS: TWO MILLION ONLY (Php 2,000,000.00)**, inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
