and

NEW PERSPECTIVE MEDIA FZ LLC, a private entity with business address at Podium 1 Office 81 Tower 2, Entrance 10, YAS Creative Hub, YAS West, Abu Dhabi, UAE, represented herein by its **GENERAL MANAGER DR. KAREN GRACILES LIBARIOS REMO** (the "Consultant");

WHEREAS, the Procuring Entity is desirous that the Consultant execute the *Contract for the Procurement of Consulting Services for the Production, Content-Creation and Printing of the Muslim-Friendly Travelogue of the Philippines*/DOT-BAC-REI No. 2024-009 (hereinafter called 'the Works') and the Procuring Entity has accepted the bid for **One Million Four Hundred Eighty-Four Thousand Pesos (PhP1,484,000.00)**, inclusive of applicable taxes by the consultant for the execution and completion of such Consulting Services for a period **three (3) months from receipt of the Notice to Proceed**, and the remedying of any defects therein;

 - h. Eligibility requirements, documents and/or statements;
 - i. Performance Security;
 - j. Notice of Award of Contract and the Bidder's conforme thereto;
 - k. Other contract documents that may be required by existing laws and/or the Procuring Entity.
 3. In consideration of the payments to be made by the Procuring Entity to the Consultant

as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.

4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
