BAC Resolution Recommending the Use of Negotiated Procurement-Small Value Procurement as an Alternative Method of Procurement, Declaring the Single Calculated and Responsive Quotation and Recommending Award to Jimwell Travel and Tours for the Transportation Requirement for Inspection, Evaluation and Processing of Accreditation of Tourism

WHEREAS, the Department of Tourism National Capital Region (DOT NCR) Tourism Regulation Division (TRD) through the General Services/Procurement Unit, posted the Request for Quotation (RFQ) for the Transportation Requirement for Inspection, Evaluation and Processing of Accreditation of Tourism Establishment in PhilGEPS and DOT website continuously for at least three (3) calendar days, starting on 15 May 2024, and the deadline for the submission of quotations was set on 21 May 2024. And a copy of PhilGEPS and DOT Website posting is hereto attached, and made an integral part hereof;

WHEREAS, the Approved Budget for the Contract (ABC) is **Pesos: One Hundred Seventeen Thousand only (PhP 117,000.00)**:

WHEREAS, Ninety-eight (98) known service providers were invited to join by sending Request for Quotation (RFQ) via e-mail and to submit their quotation via personal service and or through courier, in compliance with the procedure on Negotiated Procurement - Small Value Procurement pursuant to Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184);

WHEREAS, in response to the said posting and invitation, only one (1) prospective bidder submitted its quotation within the set deadline for the submission of quotations on 21 May 2024, to wit:

A copy of the Abstract of Quotation and the submitted quotation are hereto attached respectively, and are made integral parts hereof.

NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT- NCR Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:

- a) To adopt Negotiated Procurement-Small Value Procurement under Section 53.9 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 for the Transportation Requirement for Inspection, Evaluation and Processing of Accreditation of Tourism Establishment;
- b) To declare Jimwell Travel and Tours, as the **Single Calculated and Responsive Quotation** and to award the contract for the Transportation Requirement for Inspection, Evaluation and Processing of Accreditation of Tourism Establishment in the amount of Pesos: One Hundred Twelve Thousand Five Hundred (PhP112,500.00), inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
