RESOLUTION NO. 2024-070

BAC Resolution Recommending the Use of Negotiated Procurement – Lease of Real Property and Venue as an Alternative Method of Procurement, Declaring the Single Calculated and Responsive Quotation and Recommending Award to THE FATTED CALF FARMHOUSE KITCHEN (SYCIP CULINARY CONCEPTS OPC)

WHEREAS, the Department of Tourism – National Capital Region (DOT-NCR), through the Tourism Development Division (TDD), will be supporting the Food and Wine Festival 2024 on July 12-21, 2024. The DOT-NCR is in need of events venue that will also provide tent rentals, event host, coordination team and crew meals including photo and video coverage. The Approved Budget for the Contract (ABC) is **Six Hundred Seventy Thousand Only (Php 670,000.00)**;

WHEREAS, Section 53.10 of the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), allows the Procuring Entity to resort to Negotiated Procurement – Lease of Real Property or Venue for official use;

WHEREAS, pursuant to Clause 9 of Annex H of Republic Act No. 9184 and its Revised Implementing Rules and Regulations, the DOT-NCR Bid and Awards Committee (BAC) shall send the Request for Quotations to at least three (3) events venue/hotel;

WHEREAS, the Request for Quotation was sent via email to the following hotel/venue within Makati City and to submit their quotations on or before 4 July 2024, to wit:

1. The Fatted Calf Farmhouse Kitchen (Sycip Culinary Concepts Opc)
2. Antonio's
3. Marcia Adams

WHEREAS, in response to said invitation, only one (1) bidder submitted its quotation on 09 July 2024, to wit:

WHEREAS, the quotation submitted by The Fatted Calf Farmhouse Kitchen (Sycip Culinary Concepts Opc), being the Single Calculated and Responsive Quotation, was in accordance with the Market Study prepared by the Project Officer pursuant to Appendix C with guidelines for Lease of Privately Owned Real Property and Venue. A copy of the Market Study is hereto attached, as an integral part hereof;

NOW, THEREFORE, foregoing premises considered, **WE**, the Members of the DOT-NCR Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:

- a) To adopt Negotiated Procurement – Lease of Venue under Section 53.10 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (R.A 9184) for the procurement of Lease of Venue that can also provide tent rentals, event host, coordination team and crew meals including photo and video coverage for the Food and Wine Festival 2024 on July 12-21, 2024, and;
- b) To declare The Fatted Calf Farmhouse Kitchen (Sycip Culinary Concepts Opc) as the Single Calculated and Responsive Quotation and to award for the Food and Wine Festival 2024 on July 12-21, 2024, in the total amount of **PESOS: SIX HUNDRED SEVENTY THOUSAND ONLY (Php 670,000.00)**, inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
