**BAC Resolution Recommending the Use of Negotiated Procurement – Lease of Real Property and Venue as an Alternative Method of Procurement, Declaring the Single Calculated and Responsive Quotation and Recommending Award to BARBARA’S FOODS, INC.**

**WHEREAS**, the Department of Tourism – National Capital Region (DOT-NCR), through the Tourism Development Division (TDD), is in need of an events venue with buffet lunch and with performers for the hosting of the familiarization tour for 2GO Group, Inc. in Manila on December 5, 2024. The Approved Budget for the Contract (ABC) is **Two Hundred Eighty-Three Thousand Seven Hundred Ten Only (Php283, 710.00)**;

**WHEREAS**, Section 53.10 of the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), allows the Procuring Entity to resort to Negotiated Procurement – Lease of Real Property or Venue for official use;

**WHEREAS**, pursuant to Clause 9 of Annex H of Republic Act No. 9184 and its Revised Implementing Rules and Regulations, the DOT-NCR Bid and Awards Committee (BAC) shall send the Request for Quotations to at least three (3) events venue;

**WHEREAS**, the Request for Quotation was sent via email on December 02, 2024 to three (3) venue/restaurants located in Intramuros, Manila and to submit their quotations on or before 04 December 2024:

**NOW, THEREFORE**, foregoing premises considered, WE, the Members of the DOT-NCR Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:

- a) To adopt Negotiated Procurement – Lease of Venue under Section 53.10 of the revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (R.A 9184) for the venue with food and performers for the hosting of the familiarization tour for 2GO Group, Inc. in Manila on December 5, 2024 and;




- b) To declare **BARBARA'S FOODS INC.**, as the Single Calculated and Responsive Quotation and to award the contract for Lease of Venue for the hosting of the familiarization tour for 2GO Group, Inc. in Manila on December 5, 2024 in the total amount of **PESOS: TWO HUNDRED EIGHTY-TREE THOUSAND SEVEN HUNDRED TEN ONLY (Php283,710.00)**, inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
