



**Invitation to Bid for the Procurement of
Semi-Expendable ICT Expenses
DOT-BAC-IB NO. 2024-021**

1. The *Department of Tourism (DOT)*, through the *General Appropriation Act 2024* intends to apply the sum of *One Million Two Hundred Twenty-Nine Thousand One Hundred Seventy Pesos and 31/100 (PhP1,229,170.31)* being the ABC to payments under the contract for “*Procurement of Semi-Expendable ICT Expenses*” Bids received in excess of the ABC shall be automatically rejected at bid opening. 2. The **DOT** now invites bids for the above Procurement Project. Delivery of the Goods is required within the dates provided in the Schedule of Requirements and Technical Specifications. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary **“pass/fail”** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **DOT-BAC Secretariat** through the contact details given below during **8:00 a.m. to 3:00 p.m. Monday to Friday Excluding holidays** and inspect the Bidding Documents as posted on the websites of the **DOT** and the **Philippine Government Electronic Procurement System (PhilGEPS)**.

A complete set of Bidding Documents may be acquired by interested bidders from **12 July 2024 to 31 July 2024 (8:00 a.m. to 3:00 p.m.)** and to **01 August 2024 (until 9:00 a.m.)** from the given address and website(s) below **and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the total amount of Five Thousand Philippine Pesos (PhP5,000.00). 7. Bids must be duly received by the BAC Secretariat through manual submission **on or before 01 August 2024 at 09:00 a.m. only** at the office address indicated below. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **01 August 2024 at 10:00 a.m.** at the given address below
10. All documents shall be current and updated and **any missing document in the checklist is a ground for outright rejection of the bid.** Bidder shall submit **one (1) original** and **five (5) photocopies** of the first and second components of its bid in sealed envelope.

To facilitate the evaluation of the bids, bidders are advised to follow the arrangement in the checklist when placed in an Envelope, with documents bounded, tabbed and labeled accordingly.

The **DOT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
