V. BACKGROUND

The Department of Tourism (DOT), through its Cultural Tourism team, is actively developing Food and Gastronomy Tourism as one of its priority sub-sectors. As part of this initiative, the DOT is incorporating the principles of Slow Food to promote sustainable tourism within the Food and Gastronomy sector.

Terra Madre Salone del Gusto is one of the largest gatherings of Slow Food advocates worldwide, held biennially in Turin, Italy. It focuses on sustainable agriculture and travel, with a vision of creating a better future, fighting for good, clean and fair food. Last 26 to 20 September 2024, the DOT participated in Terra Madre Salone del Gusto 2024 in Turin, Italy. A key highlight was the signing of a Memorandum of Agreement (MOA) designating Bacolod City, Negros Occidental, as the official hub of Slow Food in Asia.

Locally, Terra Madre Visayas serves as a regional edition of the global event. For this year's edition, from 19 to 23 November 2024, the event will be held in Bacolod to officially announce Bacolod City, Negros Occidental, as the Slow Food hub in Asia.:
