

## BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending Award for the Procurement of Events Management Services for the 30th Thai International Travel Fair (TITF) 2025 DOT-BAC-IB NO. 2024-034

## Resolution No. 2024 - 181

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Events Management Services for the 30th Thai International Travel Fair (TITF) 2025 in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least twenty-one (21) calendar days, starting on 16 November 2024. The total Approved Budget for the Contract (ABC) of One Million Three Hundred Fifty Thousand Pesos (PhP1,350,000.00) inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as Annex "A", and made an integral part hereof;

**WHEREAS**, a Pre-Bid Conference was held on 25 November 2024 which was attended by BCB EVENTS AND MARKETING MANAGEMENT INC.

**WHEREAS**, the BAC issued Supplemental/Bid Bulletin No. 1 announcing amendments to the schedule of procurement activities. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex** "B" and made an integral part hereof;

**WHEREAS,** in response to said posting, **two (2)** interested bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 11 December 2024. Namely:

- 1. BCB EVENTS AND MARKETING MANAGEMENT INC.
- 2. TEN-O-FIVE PRODUCTIONS INC.

**WHEREAS**, during the opening of bids held on 11 December 2024, both bidders were declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

- a) To declare BCB EVENTS AND MARKETING MANAGEMENT INC.as the Lowest Calculated and Responsive Bid (LCRB) for the Procurement of Events Management Services for the 30th Thai International Travel Fair (TITF) 2025 and award the contract in the total amount of One Million Two Hundred Seventy-One Thousand Seven Hundred Pesos (PHP1,271,700.00), inclusive of applicable taxes; and
- b) To recommend for approval of the Secretary of Tourism the foregoing findings.
