



**BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending Award for the Procurement of Travel and Tour Operator for the conduct of Department's Hosting of the UN Tourism Events in the Philippines on June 26-28, 2024 in Cebu, Philippines
DOT-BAC IB NO. 2024-015**

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Travel and Tour Operator for the Department's Hosting of the UN Tourism Events in the Philippines on June 26-28, 2024 in Cebu, Philippines** in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 28 April 2024. The total Approved Budget for the Contract (ABC) of **Four Million Forty-Four Thousand Seven Hundred Eighty-Seven Pesos and 90/100 (PhP 4,044,787.90)** inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, the Competitive Bidding Procedures for Goods and Services pursuant to the provisions of Republic Act No. 9184 (RA 9184) and its Implementing Rules and Regulations (IRR) was undertaken for purposes of this project;

WHEREAS, the Bids and Awards Committee issued a Notice of Postponement announcing adjustments in the procurement schedule. A copy of Notice of Postponement is hereto attached, marked as **Annex "B"** and made an integral part hereof;

WHEREAS, pursuant to the said Pre-Bid Conference, the BAC issued Supplemental/Bid Bulletin No. 1 announcing clarification and amendments in the Bidding Documents. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "C"** and made an integral part hereof;

WHEREAS, in response to said posting, **two (2)** interested bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 21 May 2024, namely:

1. CCT 168 TRAVEL AND TOURS CORP.
2. JJA TRAVEL AND TOURS

WHEREAS, during the opening of bids held on 21 May 2024, all two (2) bidders were declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:
