and

GOLDEN JADE TRADING SERVICE CO., LTD. a private entity with business address at 491/A5 No. Trang Long, Ward 13, Binh Thanh District, Ho Chi Minh City, Vietnam, represented herein by its DIRECTOR NGUYEN THI MAI THANH ("Consultant").

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the Contract for the Procurement of a Tourism Destination Marketing Company for Vietnam/DOT-BAC-REI No. 2024-014 (hereinafter called 'the Works') and the Procuring Entity has accepted the bid for One Million Eight Hundred Sixty-Two Thousand Six Hundred Ninety-Seven Pesos and 43/100 (PhP1,862,697.43), inclusive of applicable taxes and bank charges by the consultant for the execution and completion of such Consulting Services, with contract delivery period of four (4) months from receipt of Notice to Proceed, and the remedying of any defects therein.

Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - Eligibility requirements, documents and/or statements;
 - i. Performance Security;
 - j. Notice of Award of Contract and the Bidder's conforme thereto;
 - Other contract documents that may be required by existing laws and/or the Procuring Entity.
- 3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and

complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.

4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
