C. BACKGROUND

The 22nd edition of the East Mediterranean International Tourism and Travel Exhibition (EMITT) will be held from January 25 to 28, 2018 at the Tüyap Exhibition Centre – Beylikdüzü in Istanbul, Turkey. The annual travel fair is organized by the EKIN-ITE Group with the support of the Turkish Republic's Culture and Tourism Department, in partnership with TUROFED (turkey Hoteliers Federation), TYD (Tourism Investment Association), and is sponsored by the THY Corporation, and the EMITT Exhibition.

The 24th holding of the event, will be held at the TLV Convention Center in Tel Aviv, Israel from February 6 to 7, 2018. It is the largest annual professional tourism fair of its kind in the Eastern Mediterranean that serves to promote incoming tourism, domestic tourism and outgoing tourism, as well as strengthen cooperation among tourism bodies in Israel and elsewhere in the world.
