IMPLEMENTATION : November 25-29, 2021

OBJECTIVE

SCOPE OF SERVICE

The service provider should be able to provide the meals, transportation, transfers, accommodation, and load cards with the following specifications:

A. GENERAL REQUIREMENTS:

- Must be a DOT- Accredited Tour Operator
- Inclusive Date: November 25-29, 2021
- Amenable to send-bill arrangement/government procedure
- Price quotation should be denominated in the Philippine Peso and inclusive of 12% VAT and all other applicable taxes and charges. Price validity shall be for a period of one hundred twenty (120) calendar days.
- Tour Operator or must be based in NCR, or Region IVB (MIMAROPA)
- Must have experience providing services to the DOT and other government agencies

1. Mayor's/Business Permit
2. Proof of PhilGEPS Registration
3. Omnibus Sworn Statement
4. DOT Accreditation Certificate

C. DELIVERABLES

Transportation - November 25 - 29, 2021

Van Rental - 2 units

- Whole day
- Must have available sanitary care kits such as face mask, face shield, alcohol, and gloves good for fifteen (15) pax for five (5) days
- Driver must have a negative RT-PCR or Antigen Test at least 2 days before the event

Accommodation - November 25 - 29, 2021

Must provide room accommodation for the following:

- November 25-29, 2021 5D4N (15pax)
- Hotel shall be near to SMX Convention Center Manila for easy access to accommodation
- Hotel must be DOT-Accredited with Certificate of Authority to Operate (CAO)
