I. PROJECT: Russian Media Familiarization Trip to the Philippines

II. BACKGROUND:

5 Russian journalists, 1 DOT Market rep, 1 OPMD and 1 Russian speaking guide
Date/Period Covered: December 8 to 15, 2018
Destinations: Manila / Bohol

III. PURPOSE/OBJECTIVES

The Department of Tourism is in need of the services of a DOT-accredited local tour operator in the Philippines engaged in the business of providing tour packages or its components to handle and coordinate arrangements for the familiarization trip for Russian journalists. The project is aimed at attaining the following objectives:

1. To project the dynamism of the country by continuously providing new interest topics on the Philippines and generate media mileage;
2. To sustain the presence of the Philippines in Russia and consistently generate content on our key travel destinations, products, and facilities; and
3. To further entice Russian tourists to convert their interest into actual travel through feature stories of our other islands appealing to their need for warm climate and diversity of activities.

IV. MINIMUM REQUIREMENTS FOR SUPPLIERS

- a) Must be a DOT-accredited tour operator;
- b) Has actual experience in handling travelers from the abovementioned areas;
- c) Has actual experience in handling media groups;
- d) Willing to provide services on send-bill arrangement (60 days).

V. SCOPE OF WORK/DELIVERABLES

- 1) Transportation service requirements including:
 - a. Domestic airline tickets inclusive of terminal fee and 20 kilos baggage allowance:
 - i. 09:10am flight from Manila to Tagbilaran (Bohol) – Dec. 8¹⁰ (8 pax)
 - ii. 11:15am flight from Tagbilaran (Bohol) to Manila – Dec. 15 (8 pax)
 - b. Airport hotel transfers – based on the above and upon arrival/departure from Manila
 - c. Transportation for the tours
- 2) Cover all accommodations on single occupancy basis (with breakfast) in the following establishments in the following destinations on the following dates:
 - a. Dec. 8-10 (3D/2N) – at 5-star / deluxe hotel in Makati or Pasay cities (6 deluxe rooms)
 - b. Dec. 10-15 (6D/5N) – at least 3 to 5-star resort/ hotel in Bohol (8 deluxe rooms)

 - d. Extreme Adventure Tour (Danao Adventure Park, Zipline, The Plunge, Glass Walk) on December 12
 - e. Island Hopping (Balicasag Island and Virgin Island with Snorkeling and, Diving), on December 13
 - f. Laze Around Panglao (Dumaluan White Beach, Bee Farm Tour, Hinagdanan Cave, Our Lady of Assumption Shrine, Daus Church) on December 14

- 5) Submission of the following documents upon completion of the project for facilitation of payment:
