### III PURPOSE/OBJECTIVES

The Philippine Department of Tourism (PDOT) is in need of services of a local tour operator or travel agency in the Philippines engaged in the business of providing international/domestic air tickets, accommodations, tours inclusive of Chinese-speaking guide, meals, transportation and ground handling services.

## IV. MINIMUM REQUIREMENTS FOR SUPPLIERS:
