



## REQUEST FOR EXPRESSION OF INTEREST

The Department of Tourism, through its Bids and Awards Committee (BAC) invites consultants to apply for eligibility and shortlisting, and if found shortlisted, to bid for the hereunder project, short of award:

Name of Project: **Procurement of Services for the DOT Accreditation Campaign-Media Plan and Placements**

Brief Description: To identify media channels and platforms that will cater to the international market that are keen on booking establishments and tour operators.

Approved Budget for the Contract: Fifty Million Philippine Pesos (PhP50,000,000.00)

Contract Duration: September to December 2019

The list of minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using non-discretionary "pass/fail" criteria. Shortlisting of eligible consultants will be done based on the following criteria:

**The Minimum Passing Score is 80%.**

Only five (5) eligible consultants shall make up the shortlist. The evaluation procedure to be adopted shall be Quality Based Evaluation (QBE).
