The Department of Tourism – Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered service providers to bid for the hereunder project:

Name of Project:	Procurement of Ground Handling/Tour Operator Services for the Austrian Agents Familiarization Trip to Metro Manila, Siargao, Cebu, and Bohol
Brief description of the Project:	DOT-accredited local tour operator engaged in the business of providing domestic air tickets, tours, and ground handling services.
Approved Budget for the Contract:	Two Million Four Hundred Eighty-One Thousand Six Hundred Thirty Philippine Pesos and Fifty Centavos (PhP2,481,630.50)
Contract Duration:	September 10 to 20, 2019

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding.
