I. PROJECT DETAILS

Project Title: "BELENISMO SA TARLAC"
Media Familiarization Tour 2019

Destination: Tarlac Province

Period Covered: December 15-16, 2019 (Overnight)

Number of Pax: 15 PAX

Type of Fam-Tour: Complete Package Tour

II. BACKGROUND

The media familiarization trip for DOT's media partners is a regular project activity included in the Work Program for 2019 of the Office of Public Affairs and Advocacy (OPAA). It aims to promote international and domestic tourism, generate a favorable image and a wider publicity for the DOT; and engage the media as an active partner in

promoting sustainable tourism development.

The annual Belenismo sa Tarlac is a life-size belen-making competition featuring over 50 Nativity scenes, which has increasingly been an international and domestic tourist attraction. The scenes light up town halls, plazas, churches, business establishments and communities along Manila North Road and Romulo Highway in the western part of Tarlac Province, offering night travelers a fascinating visual treat.

This fam-tour will give the media participants a great photo opportunity on the start of the traditional Simbang Gabi on midnight Sunday, December 16, 2019.

This fam-tour also aims to feature and promote Tarlac's tourist attractions, including heritage sites, eco-farm and food destinations that have attractive potentials in the world tourism market. Belenismo sa Tarlac is chosen for this fam-tour project for its accessibility, sound tourism infrastructure and accommodations, natural and cultural tourist attractions; and highly recommended by our DOT Region III Office.

III. OBJECTIVES

- To promote international and domestic tourism by generating a favorable image and a wider publicity for the DOT
- To engage the print, broadcast and social media practitioners to produce and publish more releases from the DOT
- To engage the media, an active partner in tourism development in the propagation of the culture of sustainable tourism.

4. Accommodation for 15 PAX for one (1) night/two days (twin-sharing), Check-in December 15, 2019, Check-out December 16, 2019, strong Wi-Fi
5. Full board meals to cover breakfast, lunch, dinner, AM and PM snacks, and mineral water, juices during trips
6. Free use of amenities including swimming pool, parking area)
7. Provision for entrance & other fees
8. Provision for domestic travel insurance
9. Miscellaneous (first aid medicines)
