TERMS OF REFERENCE

Cloud Hosting and Storage Subscription for the DOT Accreditation Online System

I. OBJECTIVE:

1. To provide access and online connectivity to the DOT Online Accreditation System.

2. Ensure availability and continuity of the Online Accreditation System.

II. MINIMUM REQUIREMENTS FOR SUPPLIERS:

1. Able to provide Twelve (12) months subscription for online hosting and storage to access the online accreditation system.

2. Must directly manage the dedicated DOT Servers.

3. Must have 24/7 technical support for server.

4. 99.99% service level availability, no downtime, no slowdown, and no interruption.

5. Must provide two (2) Servers, 1 Main Server and 1 Back-up Server;

6. Both servers must be a Linux Dedicated Server with the following minimum specification:

a. >= 8 CPU Cores @ 3.3 GHz

b. >= 64 GB memory

c. >= 8 TB storage solid-state drive RAID

d. >= 15 TB bandwidth

e. Other Specs:

 2. The firm may report to the Office of Tourism Standards and Regulation (OTSR) and DOT IT Division for updates or concerns, if needed.
 3. Prepare quarterly status report of cloud storage maintenance and activities.

 2. Must be able to provide backup of all the data regarding the online accreditation system within 15 days before the contract ends.
