- 2. Bid Security
- Department of Trade and Industry (DTI) business name registration or SEC Registration Certificate, whichever may be appropriate under existing laws of the Philippines, supported with the necessary information using the prescribed forms
- 4. Valid and current Mayor's permit/municipal license
- 5. Statement of ongoing Government and private contracts including contracts awarded but not yet started
- 6. Statement of all Completed Government and private contracts which are similar in nature
- 7. Statement of Single Largest Completed Contract
- 8. Tax Clearance

  - b. Certification under oath that each of the documents submitted in satisfaction of the eligibility requirements is an authentic copy of the original, or a true and faithful reproduction of the original, complete, and that all statements and information provided therein are true and correct.
  - c. Letter authorizing the TSU BAC or its duly authorized representative/s to verify any or all of the documents submitted for eligibility check
  - d. Statement that the signatory is duly authorized representative of the prospective bidder, and granted the full power and authority to do, execute and perform any and all acts necessary and/or to represent the prospective bidder in the bidding
  - e. Sworn Affidavit of compliance with the Disclosure Provision under Section 47 of the Act in relation to other provisions of RA 3019
  - f. Statement that it complies with the responsibilities of a prospective bidders or eligible bidder
  - g. Duly notarized Certificate in compliance with existing labor laws and standards, in the case of procurement services
