BACKGROUND:

The media familiarization trip for DOT's media partners is a yearly project activity of the Office of Public Affair and Advocacy (OPAA) and is included in OPAA's Work Program for 2019, aimed to reward the top producers of 2018 from various media outfits that have continuously supported and covered the Department of Tourism and the tourism industry.
