I. BIDDER : Tour Operator

II. PROJECT TITLE : Cultural Food and Gastronomy Audit and Caravan of Bulacan,

Pampanga and NCR

1. February 8 – 11, 2021 (Audit run / 5 pax) 2. February 22 – 25, 2021 (Caravan / 10 pax)

### III. PURPOSE/OBJECTIVES

The Philippine Department of Tourism (PDOT) is in need of the services of a DOT-accredited local tour operator engaged in the business of providing ground handling services – tourist transport services, accommodations, meals, culinary tours, tour guiding services, etc. for the conduct of Cultural Food and Gastronomy tourism audit run and caravan to Bulacan, Pampanga and NCR

The objectives of the Cultural Food and Gastronomy audit and caravan to these destinations are the following:

- Integrate "fun and enjoyment" with authentic Filipino cultural food and gastronomy experiences in discovering Philippine destinations, and introduce cultural food and gastronomy tourism products for the domestic and international markets.
- 2. Develop food and farm tourism products with authentic cultural experiences to support sustainable tourism and support the Department's Domestic Tourism Promotions Program (to help reboot tourism activities in MGCQ areas);
- 3. Support regional food tourism stakeholders by providing a venue for them to:
  - a. Generate awareness and demand for their products and services;
  - b. Develop and enhance their skills and capabilities in re-imagining food tourism products and services;

- **E.** Ground arrangement for tour package (tourist transport services with social distancing considerations, single occupancy accommodations, toll and entrance fees, environmental fees, guided tours and special culinary demonstrations / activities, full board meals, and other related services)
- F. Provision of participant's guidebook
- G. Provision of tour coordinator to assist guests throughout the travel period
- **H.** Provision of hygiene kits and first aid kits for each participant
- I. Provide an extended / longer option dates (without penalties or price increase) and option for re-booking of actual (audit and caravan) tour dates and cancellation (without penalties)
