I. PROJECT TITLE

Crisis Management in the New Normal

II. PROJECT BACKGROUND

The Department of Tourism (DOT) – MIMAROPA is introducing new online learning sessions that provide lectures and coaching to the tourism stakeholders and local tourism officers in the Region to provide value added service in ways to mitigate the COVID-19 pandemic impact.
