Description

Background

In the interest of the continuous support for the recovery of the tourism industry from Covid19 pandemic and further protect the tourism workers, the Department of Tourism along with other concerned government agencies worked for the prioritization of the vaccination of tourism workforce.

Moreover, the Secretary included among the program activities a ceremonial vaccination in the LGUs of Palawan particularly Coron, El Nido and Puerto Princesa City. Palawan is one of the major tourism destinations in the country and employs thousands of tourism workers.

Objectives

1. Support the recovery of the tourism industry through the vaccination of the tourism workers;
2. Give recognition to the efforts and endurance of the tourism workforce despite the circumstances the pandemic has caused to the industry;
3. Give recognition to the support from the LGUs to the tourism industry and its workers;
4. Inform and encourage the other tourism workers to be vaccinated.

Minimum Requirements

1. Must be a DOT accredited service provider located in Palawan Province
2. Must be able to implement the travel bubble policy and must comply with the minimum standard of health and

safety protocols;

3. Must have experience providing services to officials and executives of different government agencies; and
4. Must be able to provide services on a Send-Bill Arrangement.
