INVITATION TO BID (IB)



The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

- Name of Project:** Procurement of Six (6) Units of Motor Vehicles
- Brief description of the Project:** To purchase six (6) units of motor vehicles to implement the first year requirement of re-fleeting of DOT's service vehicles
- Approved Budget for the Contract:** Nine Million Three Hundred Fifty Thousand Philippine Pesos (PhP 9,350,000.00)
- Contract Duration:** Please see attached Terms of Reference

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Check, Preliminary Examination of Bids, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
