TERMS OF REFERENCE

Background

The Department of Tourism shall purchase 6 units of motor vehicles to implement the first year of Re-fleeting of DOT's service vehicles.

In compliance with Republic Act No. 9184 known as "Government Procurement Act", the DOT will be conducting a public bidding for the purchase of motor vehicles.

Objective

The DOT shall purchase motor vehicle in accordance with the required technical specification to augment the service of the agency.

Approved Budget for the Contract (ABC)

The approved budget for the contract is *NINE MILLION THREE HUNDRED FIFTY THOUSAND PESOS (Php 9,350,000.00)* inclusive of all taxes and will be sourced from General Appropriation Act of 2018.
