# **Description**

## TERMSOFREFERENCE

I. PROJECT: Subscription to Conference/Webinar-based Solutions for the Conduct of DOT-OIMD Online Learning Courses

### II. BACKGROUND

The Office of Industry Manpower Development has pivoted to the conduct of Online Learning Courses as an alternative to the regular training programs (face to face trainings) being offered by the DOT, in view of the extended community quarantine brought about by the COVID-19 pandemic.

Moreover, the conduct of online learning courses will be pursued by the OIMD to ensure the continuous retooling, reskilling and upskilling of the tourism workforce even beyond the pandemic.

Thus, OIMD need to acquire a software-based conference/meeting solution to be able to accomplish its mandate in the development of tourism human capital.
